Summary of our Conditions for Hosting Students

- **1.** Provide a quiet place in the home with a desk or table where the student may study.
- 2. Allow students to utilise all communal areas of the house in the same way as any family member. Please ensure that these areas are always clean and tidy.
- **3.** The students room must be in a good state of cleanliness and repair and have adequate heating and ventilation. The room should be sufficiently spacious with natural light (windowless rooms are not acceptable), equipped with a standard sized bed and mattress (camp beds, bunk beds, futons and sofa beds are not acceptable) and adequate hanging and drawer space for clothes. The room must allow for the student to keep their possessions and store their suitcase.
- **4.** If you have more than 1 room, you must clearly indicate to the accommodation officer which room will be used for each student. You must also state the details of other students or guests who will be staying with you at the same time as an inlingua student.
- 5. Once a week you must clean the students room and provide fresh bed linen and towels. Please also provide a weekly laundry service to wash the students clothes.
- 6. Meals will be provided as agreed and will offer a varied and well-balanced diet, taking into account any reasonable dietary requirements expressed by the student. All students are expected to eat the same meals as other members of the family at the same times, unless timing issues occasionally prevent this. Please refrain from providing microwave meals to student. We have a suggested menu list on the back of the homestay handbook.
- 7. You may not host more than 1 student of the same nationality/mother tongue at the same time, unless requested by inlingua.
- 8. You may not host a student under the age of 16 at the same time as a student over the age of 18.
- **9.** The host family must only use English to communicate with the students and must ensure only English is used by all family members when the student is present.
- **10.** The host family must support the school curfew times for under 18's and ensure your student is home by 21.00 if under 16 and 22.00 if under 18.
- **11.** If you intend on driving students at all in your car, the school must see your driving license and car insurance certificate before you do this. If you are hosting under 18's, you will normally be required to drive students to and from school on occasions.
- **12.** If you lend a student your bicycle please inform the school and ensure proper safety precautions have been put in place.
- **13.** You must show the accommodation officer an annual Gas safe certificate for your boiler and gas fire and undertake a fire risk assessment yearly.
- **14.** To host students under the age of 18, all members of the host family over 18 must have a valid DBS certificate. It must be an enhanced check for the purpose of 'child workforce' and be within 3 years old.

When you have read and understood the host family information booklet we would be grateful if you would sign the attached slip and return it to the school. We regret that we will not be able to place students with families who do not do this.
